**Polish Seaman Files For Political Asylum**

A crewman who jumped ship from the Polish sailing vessel Dar Pomorza filed a petition for political asylum yesterday in federal court here.

Wlodek Czach, said to be 28, was granted permission to stay in the U.S. for 90 days "or until a decision is made on his application," said Lyle Karn, district director of the Immigration and Naturalization Service.

Czach said he had a wife and 2-year-old child in Poland.

The Dar Pomorza was docked at Penn's Landing from July 1 until July 8, and was open for tours as part of Freedom Week.

**Reinert Kin Search for Will**

The brother and former husband of Susan Reinert, the Upper Merion High School teacher found murdered last month, have filed papers requiring that they be notified if any will is entered for probate in Montgomery or Delaware counties.

Philadelphia lawyer Michael B.L. Hepps said yesterday he had filed a " caveat" in courts in Norristown, Montgomery County, and Media, Delaware County, on behalf of Mrs. Reinert's brother, Patrick Gallagher, and her ex-husband, Kenneth Reinert.

Hepps said the caveat, filed July 20, notifies the counties' registers of wills to hold up processing any will of Mrs. Reinert's until Gallagher and Reinert can examine it.

BECAUSE MRS. Reinert's Ardmore home was so close to the Montgomery-Delaware county line, her will could conceivably be filed in either county.

The purpose of a caveat is to delay the processing of a will long enough to allow any interested parties to contest the document.

The nude body of Mrs. Reinert, 37, was found June 25 in the spare-tire section of her car, which was parked

at a Host Inn motel in a Harrisburg suburb. Her two children, Karen, 11, and Michael, 10, are still missing. They were last seen with their mother June 22.

An autopsy revealed that Mrs. Reinert had died by suffocation. State Police say they're "confident" of solving the murder, but so far have not disclosed whether they have any suspects.

RECENT PUBLISHED reports have described how Mrs. Reinert, shortly before her death, changed her will and took out life insurance policies for more than \$1 million that named as beneficiary a colleague she termed "my future husband."

Delaware County Register of Wills Anthony R. Semeraro has appointed First Assistant District Attorney John Riley to act as temporary administrator if or when a will is filed.
