State suspends two firms from road bidding process

GREELEY — Two Greeley highway construction firms with links to admitted hit-skipper Joe Kuntz have been suspended from bidding on state road projects, a Colorado Department of Highways spokesman said Thursday.

The two companies, Mountain Construction Inc. and Traffic Control Specialists, were notified in certified letters mailed Tuesday, according to Carl Sorrentino, a highway department spokesman.

The department also notified them of its intention to debar the firms, an administrative process that would prohibit bidding on future state projects for up to three years.

'Everyone remains a suspect'

Police focusing on 'paramilitary' groups in Berg slay case

DENVER — Controversial Denver talk show host Alan Berg was hurried quietly in Chicago while Denver police said they are focusing on "paramilitary" groups as possible being behind Berg's ambush shooting death.

Although the number of people to be interviewed number about 25, Denver police said Thursday that "everyone remains a suspect" in the shooting that killed Berg Monday in the driveway of his condominium apartment east of downtown Denver.

Chief of Detectives Don Malin said "We are looking at paramilitary groups — the Klan, Nazis, any group of that type he had problems with."

The private grade-school services at Waldman Cemetery in Forest Park III, outside Chicago, were in sharp contrast to the flamboyant on-the-air manner that made Berg among the best-known of Denver's broadcasters.

A memorial service is scheduled for 10 a.m. Sunday at Denver's Temple Emmanuel.

A veteran of several local radio stations and a short-lived television show, Berg had a 10 a.m. noon talk show on KOA Radio when he was gunned down in Forest Park III east Denver roads Monday night.
