**OLYMPIA**  
**Ecology department still wants fine paid**  
Washington's Department of Ecology still wants the \$45,000 in civil penalties assessed the U.S. Department of Energy at its Hanford Nuclear Reservation operations.  
The state department issued the penalties in February, accusing the U.S. energy office of releasing water into the Hanford Reach National Preserve, including illegally dumping of water and operating disposal sites without required ground water monitoring systems.  
The state cited five incidents that occurred in 1985.  
The federal agency formally asked the state for relief from the penalties last month. Department Director Andrew Beatty Hunter has asked the department to postpone Monday. The federal department can pay in 30 days or the Pollution Control Hearings Board, the state agency said.

**Doctor arraigned on drug charges**  
A Tacoma-area physician has been arraigned on four drug charges in Tacoma Superior Court. Judge W.L. Brown Jr. who released him on his personal recognizance.  
Dr. Thomas McDonnell of Spanaway, a family practitioner, was booked into the Pierce County Jail Friday night following a raid by several government agencies.  
Members of the county's bomb squad were called to the scene because of allegations that the doctor had hidden weapons. He was found with a .38 Smith & Wesson handgun and a .22 caliber rifle.  
McDonnell was released about three hours after his arrest, but records showed he was arrested Monday.

**Many see new judge at swearing-in rite**  
The courtroom was packed with more than 200 people as Robert Bryan, a former Kitsap County Superior Court judge, was sworn in for the U.S. District Court bench for Western Washington.  
Judge Judge Jack Tamm, giving Tacoma two full-time federal judges for the first time.  
Bryan's oath was administered Monday by Chief Judge Walter McGovern of Seattle.  
The second session was among 14 federal judgeships that were established by Congress around the country to meet court backlogs. Bryan was nominated about a year and a half ago by Sen. Dan Evans and Slide Bryan.

**Witness says Peel was with victims**  
KETCHIKAN, Alaska — A witness in John Peel's murder trial said Monday that he saw Peel with some of the victims' husbands before their deaths, at a time when Peel claims to have been asleep.  
Peel was charged with the murder of 18 people who might have been exposed to the disease by a nurse at a health center in the southeastern Alaska village of Craig in September 1982 when the fishing vessel Inverlor's eight crew members were killed. Stephen Murray, 47, was the only survivor.
